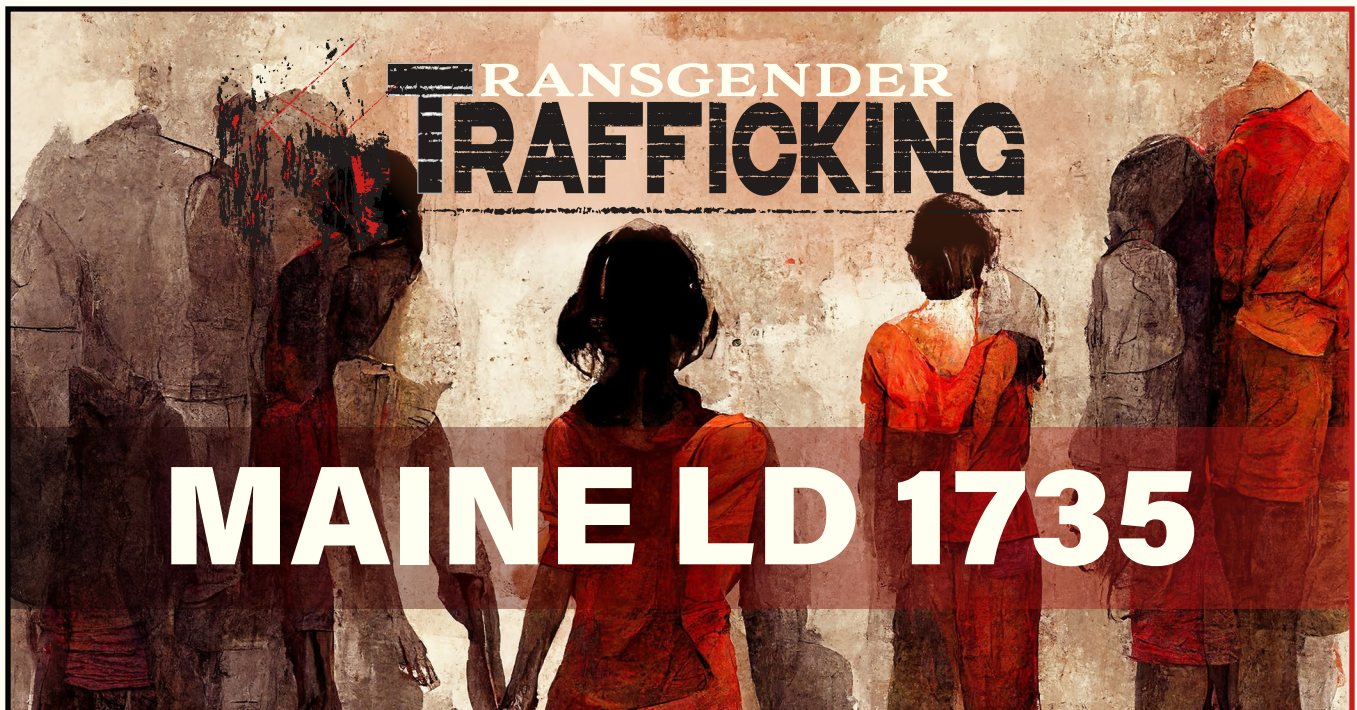
TEXT OF BILL

WHAT IS LD 1735?

This proposed **Transgender Trafficking Bill** would **permit the state of Maine to receive minors from other states** seeking transgender treatments, such as breast binding, penis tucking, irreversible puberty blockers, cross-sex hormones, or mutilation surgeries. The bill allows the state to take these minors from their parents and make them wards of the state with state-funded programs covering the cost of their treatment.

WHAT CAN PARENTS DO ABOUT IT?

There are **3 ways you can fight back** and make your voices heard, **LOUDLY** and **STRONGLY**.

1. **Live / In-Person Testimony**
2. **Live / Remote ZOOM Testimony**
3. **Written Testimony**

1. *Live / In-Person*

Give in-person testimony at the hearing:

- **Friday, May 12th, 2023**
- **Capitol Building ▪ 210 State Street, Augusta, Maine**
- **Arrive by 1:00pm ET**

Not mandatory, but highly recommended, to bring 20 copies of your testimony.

Tips on How To Prepare For Testimony

1. Prepare to wait for up to 2 hours or longer. It depends on the order of bills during the hearing. Do not leave or give up.
2. Begin with, "Good afternoon Judiciary Committee, my name is _____. I am speaking in opposition to LD 1735."
3. Prepare a 3 minute speech and a 1 minute version.
4. Since your time is so limited, make each sentence count. Be firm and direct.
5. Use facts and storytelling to drive home your points.
6. Do not come from a place of defense, ie: "I'm not transphobic because..." Those are meaningless labels.
7. Focus on parental rights and how school counselors and social workers are activists in disguise who have no right to keep secrets from you.
8. Rehearse. Record your speech on your phone and read it out loud. Play it back and make corrections. Ensure that you do not go over time.

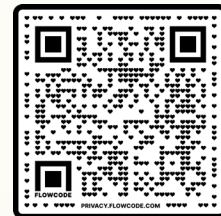
